2. **Hydro Ottawa Limited** may refuse to provide energy efficient devices and products at any time and for any reason, including due to conditions in the home that would prevent energy efficient products or devices from resulting in electricity savings, failure to meet the Home Assistance Program terms and conditions, safety conditions or lack of funds. **Hydro Ottawa Limited** MAY DETERMINE AT ITS SOLE DISCRETION WHICH ENERGY EFFICIENT DEVICES AND PRODUCTS WILL BE PROVIDED AND MAY REFUSE TO PROVIDE ANY ITEM FOR ANY REASON.

You agree that the OPA, **Hydro Ottawa Limited** and their respective contractors can contact you, including by phone or by visiting you and your home, and that you will participate in all follow up surveys, studies, audits, verifications and evaluations conducted in connection with the Home Assistance Program including for the purpose of proper administration, monitoring and verification of delivery of the energy efficient product(s), evaluation of the Home Assistance Program or to assess the performance of the Home Assistance Program, and you agree to provide reasonable access to your records and your home for such purposes.
4. **Hydro Ottawa Limited** will make best efforts not to damage your home or its contents in the course of delivering the Home Assistance Program. Nevertheless, you agree that neither the OPA nor **Hydro Ottawa Limited** nor any of their respective officers, directors, affiliates, employees or contractors and such affiliates' respective officers, directors or employees (together the "Representatives") will be liable for any injury, damage or loss to persons or property, arising from or related to the audit, installation or the use of the energy efficient devices and products, whether in accordance with the manufacturer's instructions or otherwise, or from any actions, omissions, negligence or misconduct by **Hydro Ottawa Limited**, the OPA or their respective Representatives, and you hereby release the OPA, **Hydro Ottawa Limited** and their respective Representatives of, from and against any of the foregoing.
